Issue: Re-establishing BID #29 -using the bid budget to engage a security service, garbage clean up, secure building maintenance professionals, and engage blight mitigation strategies in the area.

Issue: Concrete/Steel Garbage Receptacles - trash receptacles that would be more difficult to remove or move.

Advice from Alderwoman: The Dept of Publicworks provides for the garbage receptacles in the area. The Dept will not be able to mount the receptacle but could possibly chain them down.

The following locations will be identified as possible garbage receptacle locations in the North Teutonia Ave area. Teutonia and W. Melvina Street (eastbound and westbound on Melvina); Teutonia and W. Nash Street (eastbound and westbound on Nash); Teutonia and W. Keefe Avenue (westbound on Keefe); Teutonia and W. Keefe Avenue (eastbound on Keefe); Teutonia and W. Concordia Avenue (eastbound on Concordia); Teutonia and W. Burleigh STreet (eastbound on Burleigh); Teutonia and W. Chambers STreet (eastbound on Chambers); Teutonia and W. Hadley STreet (eastbound and westbound on Hadley); and, Teutonia and W. Center Street (eastbound and westbound on Center).

Issue: White Box/Facade Grant Program Fast Track -the current application process has proven to be too "tricky" and time consuming. Is there a way to fast track these applications?

Issue: Property Development - establishing a partnership between the North Teutonia Ave business association and the City of Milwaukee to mitigate the blight caused by City owned real estate

Advice from Alderwoman: ARCH Program Information: The ARCH Loan Programs provides matching loans of up to \$25,000 to buyers of City-owned tax foreclosed properties that will be used for art related uses or as community resources centers. The program is intended for uses that are generally available for the public. New construction on vacant land, residential properties, commercial properties and mixed-use commercial properties are eligible for the program.

Basic loan terms: 0% interest; Loan must be used for new construction or property renovation; Must be matched on a dollar for dollar basis by buyer; May be forgiven over a five year period, as long as the buyer continues to own the property and maintains the use committed to in application to the ARCH program.
